

SHERRIFF GOSLIN ROOF GIVEAWAY OFFICIAL RULES

1. No Purchase Necessary.

2. Entry into the Sweepstakes will occur from **[May 1, 2019 at 12:00 AM EST through April 30, 2020 at 11:59:59 PM EST]**. Limit of one (1) entry and one (1) bonus entry per Sweepstakes period. One eligible house will be randomly selected on or about **[Thursday, April 2, 2020 at 12:00 pm EST]** as the winner of the "Grand Prize." The winner will be selected from the pool of eligible entry. Odds of winning are based on the total number of eligible entries. A purchase will not improve odds of winning.

3. Eligibility: One entry per eligible household. Property submitted at time of entry must be a single-family detached residential property. Property submitted must be the owner's primary residence. Any submission deemed to be inappropriate, offensive or illegal will be denied at the sole discretion of Sherriff-Goslin Company. Eligible Michigan counties include: Allegan, Arenac, Barry, Bay, Berrien, Branch, Calhoun, Cass, Clare, Clinton, Eaton, Genesee, Gladwin, Gratiot, Hillsdale, Huron, Ingham, Ionia, Iosco, Isabella, Jackson, Kalamazoo, Kent, Lake, Lapeer, Lenawee, Livingston, Macomb, Mason, Mecosta, Midland, Monroe, Montcalm, Muskegon, Newaygo, Oakland, Oceana, Ogemaw, Osceola, Ottawa, Roscommon, Saginaw, Saint Clair, Saint Joseph, Sanilac, Shiawassee, Tuscola, Van Buren, Washtenaw, and Wayne. Eligible Ohio counties include: Adams, Allen, Ashland, Auglaize, Brown, Butler, Carroll, Champaign, Clark, Clermont, Clinton, Columbiana, Coshocton, Crawford, Darke, Defiance, Delaware, Fairfield, Fayette, Franklin, Greene, Hamilton, Hancock, Hardin, Henry, Highland, Holmes, Huron, Jefferson, Knox, Licking, Logan, Madison, Marion, Medina, Mercer, Miami, Montgomery, Morrow, Paulding, Pickaway, Portage, Preble, Putnam, Richland, Seneca, Shelby, Stark, Summit, Tuscarawas, Union, Van Wert, Warren, Wayne, Williams, Wood and Wyandot. Any county not specifically listed above is not eligible to enter this contest. This giveaway promotion is void wherever prohibited or restricted by law.

4. Grand Prize: One "Grand Prize" will be awarded. Maximum value of "Grand Prize" is \$10,000, based on normal and reasonable material and labor pricing for the previously described "Grand Prize". "Grand Prize" will be awarded in one of two ways:

1) Sherriff-Goslin Company will reimburse the "Winner" for the replacement, repair, and installation of a new roof on a qualifying structure submitted for a value up to \$10,000.

2) If, after May 1, 2019 but before April 30, 2020, the "Winner" purchased and installed a roof from Sherriff-Goslin, Sherriff-Goslin Company will reimburse the "Winner" for the completed installation of the before mentioned new roof, up to a maximum of \$10,000.

If the "Winner" chooses to decline both payout options they forfeit the "Grand Prize" and the "Grand Prize" will

be awarded to the next randomly selected eligible registrant based on the same rules as stated above. If the entrant does not meet the qualifications, another "Winner" will be randomly selected.
